BOARD MEETING MINUTES

N4C Fall Board Meeting September 15, 2023, Best Western, Dubuque, Iowa

The meeting was called to order 4:05 by President Greg Hoglund. Present was Greg Hoglund, Lynda Richards, Paul Hagen, Jennifer Tigges, Sonja Hoglund, Carl Hardy, Dwight Corrin, Tim Zeltinger, Paul Grillo and Drago Nemeč.

The minutes - were previously read. Dwight Corrin made a motion to accept the minutes as read. Drago Nemeč seconded the motion. Greg called for a vote and the minutes were approved.

Lynda Richards - gave the treasury report and reported a net balance of \$11,587.21. The year-to-date expenses of \$8,616.75. The expenses included a 3-year supply of ribbons and medals. We had income of \$4,112.99. The treasury report was accepted.

Paul Hagen - reported he still had awards for the Omaha Camera Club that still needed to be delivered.

Dwight Corrin - reported the judging Matrix was complete and sent to the clubs.

Jennifer Tigges - reported the Dubuque Convention was working in the black thanks to grant money they received. They plan to return the \$1500 seed money to the N4C treasury.

Carl Hardy - reported the directory is completed for the coming year and will be sent out to include any corrections from today's meeting.

OLD BUSINESS

Discussion - was made as to if we should move the Spring Convention to different locations to encourage more clubs to attend. Paul Hagen had done some research and found the center of the N4C area to be 300 miles north of the current location, at Alexandria, Mn. Tim Zeltinger reported he had found several locations near the center that would be willing to house our spring convention. Dwight Tomes suggested to be careful on the expenses to use, we have always kept the expense at a minimum. Jennifer Tigges reported that since we were committed this following spring at the current location, the next spring convention to be planned would be hers to plan. She would get together with Tim to investigate a new location for the 2025 Spring convention.

Greg thanked the Sioux City Camera club for stepping up to host the 2024 fall convention. He hopes as clubs see the success the past conventions had that other will step up to host in the future. We are still looking for a location for the 2025 fall convention. Jennifer Tigges also offered her assistance for any club willing to host a convention.

Discussion - was made of ways to recruit new clubs and members. Carl Hardy reported he had been in contact with the Cheyenne Camera Club, and they will consider the possibility of rejoining the N4C. He also talked to North Shore Camera Club, and they were not sure why they were no longer a member. Carl had also contacted other clubs that had dropped out.

NEW BUSINESS

Dwight Corrin - made a motion to modify the N4C handbook and the convention planning guide to remove complimentary hotel nights and convention admissions for the few positions it was listed for, making this a completely volunteer organization. Paul Grillo seconded the motion. The motion was passed.

Tim Zeltinger - made a motion to increase the N4C dues to \$3 per person per year with a cap of \$120 per club. Dwight Corrin seconded the motion. After much discussion the motion was defeated.

Lynda Richards - made a new motion to increase the N4C dues to \$2 per person per year with no minimum or maximum caps per club. Dwight Corrin seconded the motion. After much discussion the motion was passed.

Greg Hoglund - reported there are several N4C positions that are vacant and 3 need to be filled. Three people volunteered at the meeting to fill these positions. Supply Chair - Julie Olson; N4C Historian - Linda Rutherford indicated that she would be willing to take the boxes of hard copy information and scan it so it could be stored in digital format and get rid of the hard copies; Director #6 - Andrea Pellerito. To go along with that there are three positions that are no longer needed, the Parliamentarian Aid, Financial Committee, and the Analysis Service position.

Dwight Corrin - made a motion to abolish the Parliamentarian Aid, Financial Committee, and the Analysis Service position. These positions have not been filled or needed for years. Lynda Richards seconded the motion. The motion passed.

Paul Grillo - made a motion that we combine the Founders Award committee and the Service Award committee as one committee. Drago Nemec seconded the motion. The Motion passed.

Paul Hagan - reported that he was studying the handbook and found some changes that he thought should be addressed. Paul made a motion to make these changes See attached for details.

1. Numerous locations in the handbook changing the method of communication from mail to e-mail.
2. Taking names out of the description portion of the handbook discussing the Club Communications Competition Chair and vice chair. These will be appointed and may be different people through the years.
3. The location of the spring mini convention should be changed or left blank as it is no longer held at Springbrook State Park
4. Modifying Article VI Special Recognition adding that Francis A. Kingsbury, FPSA, Founder is Deceased.

Lynda Richards seconded the motion. The motion passed.

Greg Hoglund - reported on the slate of officers for the coming year. Ballots had been sent out but only 6 clubs had returned the ballots so far, but all clubs received had voted for the slate as presented. Director 6 was still vacant on the ballot. Andrea Pellerito volunteered to fill that position.

Drago Nemec moved a motion to accept the following slate of officers.

President - Paul Hagen; Treasurer - Lynda Richards; Secretary - Sonja Hoglund.

First Vice President - Dwight Corrin; Second Vice President - Jennifer Tigges.

Director 1 - Tim Zeltinger; Director 2 - Carl Hardy; Director 3 - Paul Grillo.

Director 4 - Drago Nemec; Director 5 - Stephonie Schmitz; Director 6 - Andrea Pellerito

Paul Grillo seconded the motion. The motion passed.

Greg Hoglund - reported that the subject of Artificial Intelligence is something we may need to have discussion as to how it will affect our contests in the future. Greg suggested we put an article in the newsletter to remind people of the rules for altered reality that the image must have a photographic base of the maker's own creation. This would rule out any image made without a camera.

Teresa Volcum - asked to retire some forms not needed anymore. Everyone agreed to dispose of them. Paul Grillo - made a motion to adjourn the meeting and Lynda Richards seconded the motion. The meeting was officially adjourned at 3:03.

IF YOUR CLUB ENTERS PRINTS, SEE BELOW FOR WHERE TO SEND ENTRIES.

FOR DIGITAL ENTRIES, they must be received by 5:00 pm November 15, however make every effort to send them by the 13th to allow time for confirmation.

- Judging may begin on the 16th - make sure you receive confirmation that entries were received.

The cutoff time will be 5:00pm on the 15th giving the judging chair time to organize them for judging starting on the 16th. The point is... don't wait until the last minute. There have been problems with occasionally missing entries when they are not received until late in the night on the 15th.

The 2023-2024 rules are on the N4C web at <http://n4c.us/competition.htm> by clicking the blue "N4C Contest Rules" button. Copy attached. Refer to those until the new N4C Handbook is available.

The N4C Directory is available by email from Carl Hardy and his email is torchenterprises72@gmail.com The Handbook contains the contest rules and other general N4C Info. The Directory contains the list of judging clubs for all the contests along with contact info for all the affiliated clubs. The Handbook is available for download from the web <http://n4c.us/Supplies-Forms.htm> page.

There are six Digital Image Contests each month - (see the definitions of each category in the Rules):

Altered Reality (DA)

Black & White (DB)

Journalism (DJ)

Nature (DN)

Pictorial (DP)

Travel (DT)

Maximum of 8 entries per club per contest, not more than one from a member in each contest

Do not enter versions of the same image in multiple contests. For example, do not enter both a color and B&W version in the same month. Likewise, don't enter both Digital & print versions. If both win, one will be withdrawn. The rule is: "Any entry which receives a 1st, 2nd, 3rd, or HM award in a monthly competition may not be re-entered in the same year or later years, in the same or any other category, regardless of variations or changes made."

Please check your entries before sending them on for judging. Look for three things:

1. File size 750KB max. (A requirement this year)

2. **Longest side 1,920 pixels max.**

3. File name should look like this example: 01,DE028,DP,Beautiful Sunset.jpg

Content of the Email Message when you send the entries:

a. Subject Line of the Email should say "N4C Contest Entries from _(your)_ Camera Club".

b. Specify which monthly contest and how many images are attached to the Email.

c. List the Member Numbers and corresponding member names to ensure that the Judging Club has that information.

d. Give the Club Name and your full name.

e. Attach the image files

ASK THE JUDGING CLUB IF YOU DO NOT GET A RECEIVED CONFIRMATION BACK FROM THEM

Please send me updated member lists when you have added Member Numbers. I'm glad to see new members participating in N4C contests. Naturally I need to get them registered so they are properly identified for the judging clubs. For new members, that really should be done a month in advance of entering.

(Entries must be received by 5:00 pm November 15, however **make every effort to send them by the 13th to allow time for confirmation.**

- Judging may begin on the 16th - make sure you receive confirmation that entries were received)
If you have any trouble reaching these judging clubs, let Ken Johnson know as soon as possible.

A club will normally have up to 8 entries for a contest. A typical image file name list might look like:

(USE YOUR CLUB NAME AND MEMBER NUMBER INSTEAD OF DA044 - zero "0" 44 not a letter "O")

(USE DA, DB, DJ, DN, DP, or DT for the Contest Code - This example is for the Digital Nature Contest)

(Notice commas separating the data in the file names) 01,DA044,DN,Deer.jpg

03,DA022,DN,Grand Arch.jpg

04,DA033,DN,Teton Reflection.jpg

05,DA037,DN,White Water.jpg

06,DA002,DN,Shadows.jpg

07,DA025,DN,Horsetail Falls.jpg

08,DA018,DN,Soaring Eagle.jpg

Members should submit entries with filenames similar to the above except for the sequence numbers. The club N4C Rep will rename the files to include the sequence numbers. The club N4C Rep may want to keep things simple for the club members and handle ALL the file naming - how this is done is left to the club. The sequence numbers will determine the sequencing of the image in the judging line-up. All the contest entries will be sorted in alpha-numeric sequence by filename so this will mix up club entries for judging. The 01's from all the clubs will be judged first and the 08's at the end.

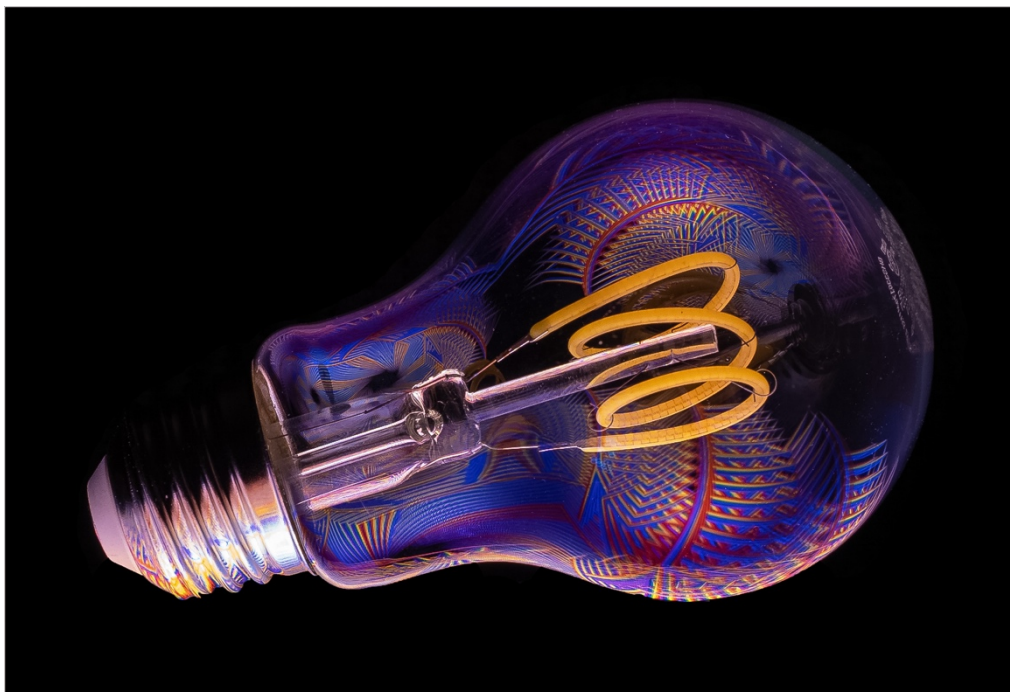
