#### **N4C President's Message**

The weather doesn't feel like summer yet, but summer will soon be here and many of you will be out shooting those award winning photographs. For this reason I will devote my message to the changes in the N4C monthly contests for next year that were approved by the N4C board at Springbrook.

The first change is in **A & B prints**. Since the original reason for A & B categories doesn't apply anymore, an attempt was made to update and make the print categories applicable to the times. Here is the change.

- Change Class A to "Large Print Category" and Class B to "Small Print Category"
- Change all reference to Class A to "Large Prints" and all references to Class B to "Small Prints."
- Print sizes for Large Print Category would be 16x20 maximum mount size with no minimum size.
- Print sizes for Small Print Category would be 11x14 maximum mount size with no minimum.
- Commercial/homemade prints will be allowed in both categories.
- A person starting in "Large Print Category" or "Small Print Category" MUST consistently enter the same Category throughout the contest year.

The second item is a new **Monthly Digital Pictorial Slide** contest. The Digital Advisory Committee, (especially Ken Johnson) has put in countless hours getting making this contest workable. Be sure to read Ken Johnson's Article on the new Digital Slide Contest.

#### Dr. Otis D. Wolfe

**Dr. Otis D. Wolfe** died March 4 in Tempe, Ariz., at the age of 94. Besides being a noted opthamologist, he was a widely known Central Iowa photographer and world traveler and described himself as "a serious amateur."

He was a charter member of the Centeral Iowa Camera Club, which began in 1977. He was also active in N4C and PSA.

He conducted a composition class at the local college and judged several Iowa Valley Photo Contests. Dr. Wolfe's "Keys to Composition" were keep it simple, less static is more pleasing, action moves left to right, angles may make or break, vertical reflects straight, horizontal reflects repose, and a tripod is a must.

In 1989-90 alone, his quest for adventure took him to the Galapgos Islands, Alaska, Nova Scotia, Yellowstone, and several monarch wintering sites in Mexico. Nature was ever dominant in his photographic art.

For nearly a decade he presented slide shows for numerous social and service organizations. His dedication to photography and wealth of knowledge was always evident.

The N4C Digital Advisory Committee feels that this type of digital contest will have wide appeal to members. The all electronic method of submitting entries, judging, and reporting results is being given a one year trial period to learn and refine the system.

The contest will be run nearly paperless. This will keep the cost to members and clubs at a minimum.

Because the system involves several new software applications, a trial period will help resolve unanticipated problems while working with up to 40 different camera clubs.

Points toward "Photographer of the Year" or "Club of the Year" will not be awarded during the trial because we don't want members and clubs to be upset if some fluke causes some inequities from month to month. Ribbons will still be awarded like other contests and all intentions are to show the Best-of-the-Best at the 2007 N4C Convention.

Features of the new system include:

- No need for entry forms.
- All entries submitted by email (or on CD).
- Entries added to judging spreadsheet without typing.
- Images projected for judging.
- Judges scores and comments tallied on the spreadsheet.
- When judging is complete, entries are sorted to bring high scores to the top.
- Ties are resolved and awards entered.
- Judge's summary of winners and statistics generated automatically.
- Report generated to send back to clubs.
- Adaptable for local club contests.

Establishing "N4C Member Numbers" allows the system to work without entry forms and prevents the entrant's name and club from being seen by the judges. Each camera club will assign these Member Numbers. Details are in the contest provisional rules.

Contest Chair **Ken Johnson** will be contacting clubs soon about participating in this contest. This contest will no doubt take some handholding and cooperation.

Contact Ken (kandsjohnson@mchsi.com) to help get started and to answer questions. During this trial it is important to make suggestions for improvement and to work out difficulties. Members of the Digital Advisory Committee are George Bebout (Chair), Ken Johnson, Dwight Tomes, Cecil Organ, and Mark Shaw.

# 2006 N4C Convention September 15, 16, 17 Sioux City, Iowa

The Sioux City Camera Club invites you to attend the N4C Convention on September 15, 16, and 17, 2006. Mark your calendar and don't miss the Golden Anniversary of the first convention. An exciting field trip and great speakers and programs are planned.

Friday's field trip will be to one of the few remaining railroad roundhouses. The golden age of steam locomotives is gone, but there are a few bits and pieces of the past that remain.

The Roundhouse operated by the Great Northern Railroad in Sioux City is now a museum. This facility consists of the maintenance shop, a roundtable, sand tower, and a number of vintage engines and cars.

The roundtable is an engineering marvel. It is not an automated machine. Four men pushing the table easily move a 60-ton locomotive. The table was used to route engines and cars into the various maintenance bays of the shop to be worked on.

The Steam Engine (GN1355) will be on display. In its prime it pulled passenger cars. At the end of its service it was used to move local freight cars in this area. Museum personnel will be dressed in the standard railroader's uniform-blue coveralls and engineer cap. If he is not riding the rails, we may even have a rail conductor in full uniform. A number of vintage cars can also be seen on the property. There are boxcars, a caboose, passenger cars, and dining car. Most can be photographed on the inside.

Another stop on the Field Trip is one of South Dakota's newest State Parks. The Adams Preserve property was homesteaded by the Adams family shortly after the Civil War. The 1200-acre property sits on the banks of the Missouri River. The original

owners probably sat on the riverbank and watched the paddle wheelers heading to the gold fields in the Montana territory.

Our interest will focused on the historic buildings on the site. They consist of a log cabin, one room school, church, and Shay-Adams house. You will have access to the interior of all these buildings. Even the locals have not been inside some of the buildings.

The prairie around the Welcome Center was burned this spring. The giant bluestem and prairie grasses and flowers should be at their prime in September. One might also see deer, turkey, and a variety of birds, bees, and butterflies.

The seminars on Saturday should spark that creative ember in all attendees.

**Jeff Morgan** of Elm Studios will talk about making better pictures, panoramics, and digital infrared photography.

Other presenters will cover framing and matte selection and painting with light. Light painting is a technique that has blossomed since the introduction of digital photography. The instant feedback allows one to tweak the picture for optimum impact. A recent demonstration at one of our club meetings had everyone talking and taking pictures.

# There is only going to be one Golden Anniversary Convention. Don't miss it!
