#### N4C President's Message-April-09

George Christensen talked to us about Composition with some fantastic Black and White photography and Available Light photography by Barbara Russell, and a photo trip to the Galapagos Island by Mike Landwehr. Then, a thanks to Gerry Bonsack, who had more fun busting light bulbs than I've seen, since I was a kid. Haha. It was an interesting photo shoot and Gerry came up with a couple of good ones again. Also, setups from Barbara Russell, Diane Darnielle, and Rick McCubin. All were fun to shoot and some new ideas, to work on.

We also had a N4C Board meeting on Friday and there are some changes coming, starting next September. I'll mention a couple here and more in letters to come. Maybe others will be writing some too. We have eliminated the Large and Small Prints as their didn't seem to be any difference in the categories. The original thought was for experienced photographers and new photographers but they were mixed together and didn't accomplish the original objective. There will be one classification of prints with a minimum of 8 x 10 inches and maximum size of 16 x 20 inches, including the mount. Another change will be in the Photo-Journalism classification. The prints are the same but entries can be slides or digital entries and will be judged together. We had a test of Panorama prints and had a good set of entries. More discussion is needed to establish a sizing method and the other question was how to judge them. It will be expensive to send them out due to the size and maybe make this a special event at Springbrook each year and the prints will be delivered and carried back home. More will be coming on this and other issues.

As far as the weather, I've seen better but I've also seen worse. But a special thanks to Larry and Delores Meister for setting this all up with Springbrook State Park. A job well done again. Dwight Tomes had a great schedule set up for the weekend.

Again, thanks to everyone who attended and participated in the weekend and hope to see you all in Duluth.


