


#### **Presidents Doug Conrad Notes:**



Francis Kingsbury is a lifelong resident of Ponca, Nebraska. He graduated from Ponca Public School and Morningside College in Sioux City, Iowa. Following graduation from college, he served three years in the U.S. Army, two of which were spent in Paris, France. Upon his return to Ponca in 1946, he joined family banking interests. He currently serves as Chairman of the board for the Bank of Dixon County, Ponca and Newcastle.

His interest in photography began in high school and continued during his college years as yearbook photographer. He feels that his serious approach to photography began when he joined the Sioux City Camera Club in 1946. His early training under the watchful eye of senior club members was in the field of traditional pictorialism. Early in the sixties, he broke away from this training and began to specialize in nature photography. For many years, he raised his own wild animals including bobcat, coyote, red fox, skunk, raccoon, great horned owl and various hawks. For several years he was included in the top ten nature exhibitors of the world. In recent years, he has turned away from nature and wildlife photography to more traditional subject matter for his photographs. He has also nutured a previously controlled interest in contemporary photography which he describes as a creative effort to depart from reality by any means available to the photographer including specialized darkroom procedures. His renewed interest in a variety of subject matter has resulted in sales to a wide range of clientele.

He has had more than 1500 prints and slides exhibited in international shows, some of which include Hong Kong, South Africa, Pakistan, Austria, Australia, and all major exhibits in the United States. He is listed in the top twenty monochrome print exhibitors as well as the top twenty color print exhibitors in the United States. In 1972, he was elected a Fellow of the Photographic Society of America in recognition of his record in international exhibiting and for his service to photography.

He has held all offices in the Sioux City Camera Club and is co-founder of the North Central Camera Club Council. His darkroom has been active for more than fifty years and continues to produce many prints each year.

#### Photo Tips from Nature and Outdoor Photographer

#### Francis A. Kingsbury, FPSA

'Fran' Kingsbury of Ponca has exhibited nature and landscape photos throughout the world as an amateur photographer. He has been named a Fellow in the Photographic Society of America, FPSA, for his service to photography and his international exhibition record. It is the highest award in international amateur photography. Mr. Kingsbury has been ranked one of the Top 5 International Nature Photographers in annual competition worldwide.

#### Photo Tips

The best time of day is early morning and early evening.

Generally, have the sun at your back.

Try front or side lighting for different effects.

Look for unique angles, and high or low camera positions.

Look for fine detail in the subject matter.

Watch the background for distracting things like wires or roads.

Have the main subject matter slightly off center.

Have the center of interest in the upper or lower one-third of the frame.

Use leading lines to the center of interest.

Turn the camera vertical, not every shot fits horizontally in the viewer.

Keep everything man-made out of scenic or nature photographs.

Never have people look directly toward the sun.

On landscapes, have something in the foreground for dimension.

For the best foreground appeal use flowers, rocks or bushes.

On landscapes, frame with tree or bush on one side for depth.

Frame a landscape with overhead branches or other objects.

Shoot wildlife at a fast shutter speed, or high speed film to stop motion.

Fill the frame; move in close.

Try close up photos of only a part of complete object.

The best photos are often unusual. Train yourself to see the unusual.

Be patient, good photographs require time.

If you see a great photo opportunity, look for a great angle to shot from.

Carry your camera at all times to get that beautiful sky or sunset.

It is better to be lucky than good, but you have to have your camera.

#### FRANCIS' OBITUARY



Francis A. Kingsbury, FPSA June 7, 1922 to January 13, 2022

Francis A. 'Fran' Kingsbury, a few months short of being 100, passed away peacefully on Thursday, January 13, 2022 at Unity Point, St. Luke's Hospital in Sioux City, IA after a short illness. Funeral Services will be held on Tuesday, January 18, 2022 at 11:00 AM at the First United Methodist Church in Ponca, NE (where Fran was a lifelong member for nearly 100 years) with Reverend Debra Welch officiating. Burial will follow at Ponca City Cemetery. Visitation, with the family present, will be on Monday, January 17th from 5:00 PM to 7:00 PM at Mohr Funeral Home in Ponca. He was born June 7, 1922 to Francis R. and Kathinca (Nielsen) Kingsbury at a Sioux City, Iowa hospital. Fran lived his entire life in Ponca where he graduated from Ponca High School in 1939. He graduated with a business degree from Morningside College in Sioux City in 1943.

He met Vernice J. Christiansen at Morningside College and they were married in Hawarden, IA on June 13, 1944. Fran and Vernice celebrated their 77 years of marriage with the family at their traditional Fourth of July gathering last summer. To this marriage three children were born: two sons James A. and John F. and a daughter Cynthia Jean. Following three years of active duty during WWII serving in the US Army Quartermaster Corps as personnel manager of an officer clothing store in Paris, France; Fran returned to Ponca to join his family's banking interests. During his more than seventy-year involvement with the

Bank of Dixon County he served as both President and Chairman of the Board for many years.

Fran offered his support and involvement in many community organizations including American Legion Chapelle Post 117, Ponca Community Club, Better Ponca Foundation, Ponca Community Educational Foundation, the Sioux City Camera Club, SCCC, N4C, the Photographic Society of America, PSA, Boy Scout Troop 200 and having been a member of the Ponca Public School Board.

Mr. Kingsbury, FPSA, nurtured a lifelong interest in photography during his more than 65 years as a member of the SCCC, N4C and PSA. Having first been elected an Associate, APSA, in the Photographic Society of America; he was elevated in 1972 as Fellow, FPSA, in the international photographic society. Fran was a co-founder of the regional nine state North Central Camera Club Council, N4C, along with Dr. Robert Cochran, APSA, of Omaha, NE and Curtis Lugg, FPSA, of Sioux Falls, SD.

He was an international print exhibitor having more than 1,500 prints shown throughout the United States and many foreign countries. While he was specializing in wildlife subject matter, he was listed in the top ten nature exhibitors in the world and received the highest Five Star PSA rating. Turning to digital photography in 2002, he moved to other subject matter including landscapes, sports, portraits and contemporary photography.

Survivors include: his two sons and their wives – Jim and Gwen Kingsbury and John and Myra Kingsbury of Ponca and a daughter Cindy and her husband Larry McManis of Stoughton, WI.; four grandchildren and their spouses – Chris Kingsbury and Abbey of Ponca, Greg McManis and Sarah, Sarah and Josh Hoesch, Kristen and Brad Horst all of Oregon, WI; and seventeen great grandchildren: Logan, Carter, Ashlyn, Sam, Henry and Archie of Ponca; Isabella, Alexia, Jaxson and McKenzie; Haley, Lydia, Wyatt and Luke; Sadie, Felicity and Ben all of Oregon, WI; sister, Lovice M. Sprugel of Kansas City, MO and many nieces and nephews.

Fran was preceded in death by his parents, his brother-in-law John E. Sprugel, his brother-in-law and sister-in-law Maynard and Grace Christiansen, sister-in-law and brother-in-law Leola and Dr. Alex Bushmer; granddaughter Jenny, other family members and countless friends.

# In Print and Digital the <u>Definition of Nature</u> has been changed.

At the N4C Board meeting held Thursday September 23, 2021, the rules for Nature competition were amended. **This amendment has taken effect immediately.** 

The change in the rule is the removal of the prohibition of cultivated plants in paragraph 6.

Nature (as amended September 23, 2012)

Nature Photography is the recording of our natural world by some photographic means. Included are all branches of nature except Archeology and Anthropology.

- 1. No photograph is worth distress or injury to any wild creature.
- 2. Nature photographs may be either black & white or color.
- 3. The hand of man shall not be present in any nature entry except where wild animals have adapted to the built environment (e.g., fence posts and other man-made objects freely adapted for use by wild creatures).
- 4. Banding or tagging on nature subjects is acceptable. Photographs at bird feeders are not acceptable if any part of a man-made feeder is shown in the photograph.
- 5. Photographs taken in zoos, animal farms, or game farms are acceptable if the hand of man is not visible.
- 6. Domestic animals, and pets are not acceptable.
- 7. Adjustments must look natural. The use of HDR, exposure blending, focus stacking, stitching, and related techniques that combine more than one image is acceptable, provided the resulting image is natural in appearance.

#### **Contest Reminders:**

FOR DIGITAL ENTRIES, they must be received by 5:00 pm February 15, however make every effort to send them by the 13th to allow time for confirmation.

- Judging may begin on the 16th - make sure you receive confirmation that entries were received.

The cutoff time will be 5:00pm on the 15th giving the judging chair time to organize them for judging starting on the 16th. The point is....don't wait until the last minute. There have been problems with occasionally missing entries when they are not received until late in the night on the 15th.

There are six Digital Image Contests each month - (see the definitions of each category in the Rules):

Altered Reality (DA)
Black & White (DB)
Journalism (DJ)
Nature (DN)
Pictorial (DP)
Travel (DT)

Maximum of 8 entries per club per contest, not more than one from a member in each contest

**Do not enter versions of the same image in multiple contests.** For example, do not enter both a color & B&W version in the same month. If both win, one will be withdrawn. The rule is: "Any entry which receives a 1st, 2nd, 3rd, or HM award in a monthly competition may not be re-entered in the same year or later years, in the same or any other category, regardless of variations or changes made."

Please check your entries before sending them on for judging. Look for three things:

- 1. File size 750KB max. (A requirement this year)
- 2. Longest side 1,920 pixels max.
- 3. File name should look like this example: 01,DE028,DP,Beautiful Sunset.jpg

Content of the Email Message when you send the entries:

- a. Subject Line of the Email should say "N4C Contest Entries from (your) Camera Club".
- b. Specify which monthly contest and how many images are attached to the Email.
- c. List the Member Numbers and corresponding member names to ensure that the Judging Club has that information.
- d. Give the Club Name and your full name.
- e. Attach the image files

#### ASK THE JUDGING CLUB IF YOU DO NOT GET A RECEIVED CONFIRMATION BACK FROM THEM

Please send me updated member lists when you have added Member Numbers. I'm glad to see new members participating in N4C contests. Naturally I need to get them registered so they are properly identified for the judging clubs. For new members, that really should be done a month in advance of entering.

04,DA033,DN,Teton Reflection.jpg

05, DA037, DN, White Water.jpg

06,DA002,DN,Shadows.jpg

Members should submit entries with filenames similar to the above except for the sequence numbers. The club N4C Rep will rename the files to include the sequence numbers. The club N4C Rep may want to keep things simple for the club members and handle ALL the file naming - how this is done is left to the club. The sequence numbers will determine the sequencing of the image in the judging line-up. All the contest entries will be sorted in alpha-numeric sequence by filename so this will mix up club entries for judging. The 01's from all the clubs will be judged first and the 08's at the end.


